## **b) Conferences/Meetings**

- On the occasion of the 70<sup>th</sup> anniversary of the proclamation of the Universal Declaration of Human Rights, an international conference titled “Human Rights 70 Years after the Universal Declaration. Stand up for Human Rights!” was organized on 6 and 7 November 2018. After the inaugural speeches and an introduction by Ioanna Kuçuradi, papers were presented by Angela Melo, Director of Policies and Programmes, UNESCO’s Human and Social Sciences Section; Süleyman Arslan, President of the Human Rights and Equality Institution of Turkey; Hanne Sophie Greeve, Vice President of the Gulating High Court of Norway, Judge at the European Court of Human Rights (1998-2004); Obaid Said Al-Shaqsi, member of the Human Rights Commission of Oman; Hilal Elver, UN Rapporteur for the Right to Food; Hüseyin Özel from Hacettepe University Economics Department; Richard Falk, UN Rapporteur for Human Rights in Palestine; Gün Kut, member of the UN Committee on the Elimination of Racial Discrimination since 2010; and Numan Hazar, Permanent Delegate of Turkey to the Council of Europe (2001-2004) and to UNESCO (2004-2006);

Two round-tables were organized: The first one was dealing with the question “Human Rights Education: Where do we stand?”. Angela Melo, H. Haluk Erdem (Ankara University), Harun Tepe (Hacettepe University, Human Rights Centre) and Yasemin Yalım (Ankara University, Department of Medical History and Ethics) participated in this round table. The second round-table was on “The Ethical Education of Human Rights”. Ercan Çamırcı (Police Director), Denizhan Dere (working on genetically modified organisms), Fatih Kalkan (Prison Personnel), Elif Dilan Kara (Ph. D. Student), Yusuf Adem Uzun (Social Worker) and Aydın Yücesoy (Medical Doctor) presented papers on the impact of the ethical education of human rights in the exercise of their profession.

The conference was closed by a video address by Federico Mayor, Former Director-General of UNESCO. Betül Çotuksöken (Vice-Rector of the Maltepe University), Bahattin Akşit (Dean of the Faculty Humanities and Social Sciences), Cemal Taluğ (Former Rector of Ankara University and President of the Association for Food Ethics), Filiz Demir (Dean of the Faculty of Communication) and H.E. Numan Hazar chaired the sessions.
